- Shares withheld by the Issuer to satisfy the Reporting Person's tax withholding obligations in connection with the vesting and settling of PRSUs on November 9, 2023.
- The reported ownership includes 87 shares acquired under the Issuer's Employee Stock Purchase Plan on November 10, 2023.
